

# NIU-HC Global Internship and Leadership Development Program

On-Campus Component: April 9 – May 7, 2018

Mexico Internship Component: May 14 - June 10, 2018

This study abroad program is coordinated by the Northern Illinois University Study Abroad Office (SAO) and the Office of Student Engagement and Experiential Learning.

**PROGRAM DATES**: The program will officially begin on Monday, April 9, 2018 on the NIU campus with a 3-credit hour, hybrid, pre-departure course to be held from April 9 – May 7. The internship component in Mexico will begin on May 14 and will end on Friday, June 10, 2018. Students will be responsible for making their own air travel arrangements. During the pre-departure course, students will work with Human Connections to plan for a departure date of May 14 with internship to run through Friday, June 10 for a total of 4-weeks. This includes the 3-week-120 hour total internship and 1-week leadership development training.

**PROGRAM DIRECTOR**: Renique Kersh, Professor of Counseling, Adult and Higher Education in the College of Education and Associate Vice Provost for Engaged Learning in the Office of the Provost in partnership with Dennis Barsema, Instructor, Department of Management.

Renique Kersh, Ph.D., has been a scholar and practitioner in the field of higher education since 1999. Dr. Kersh has had a diverse career with experience as a practitioner in the areas of college student retention, leadership education and college student success and engagement. Although, Dr. Kersh's career began in student affairs, she has spent the last several years working in academic affairs as both an administrator and a professor teaching courses in leadership, college student retention and student development theory. Dr. Kersh is an active member of the Council on Undergraduate Research, Leadership Illinois, the National Association for Student Personnel Administrators and the International Association for Research on Service Learning and Community Engagement.

**PROGRAM OVERVIEW/OBJECTIVES**: The primary purpose of this program is to provide participants with the opportunity to:

- Engage in an immersive international internship experience, leaving participants better prepared to understand and engage with local communities during their time abroad.
- Learn through dialogue and human relationships and thoughtfully consider and begin to understand the needs and capacity of diverse global communities.

 Gain leadership and professional skills through engagement in their internship and through workshops with local leaders.


Academic credit. The NIU-Human Connections Global Internship and Leadership Development (GILD) program will engage students in a 3-credit hour hybrid NIU course (INTL 201) where students will complete an online curriculum in addition to engaging in thoughtful discussion and preparatory exercises before beginning their internship. For the internship and professional development component of the program in Mexico, students will engage in an NIU-HC internship and leadership development experience in Bucerias and the Riviera Nayarit, Mexico. Upon completion of the internship experience, students will be expected to present a poster as a final capstone.

**Structure to maximize impact.** The GILD program culminates with the completion of a collaborative, creative, community-based poster, which will be presented by students at the Summer Research Symposium, Community Engagement Showcase or in another designated showcase depending upon student's degree completion date.

**PROGRAM SITES:** Bucerias and Mexico's Riviera Nayarit.

HIGHLIGHTS: The GILD internships are led by Human Connections (HC) Executive Director, Elly Rohrer, as well as other HC staff members, in collaboration with local staff and guest speakers. HC staff has conducted more than a dozen student programs in Bucerias, a small beach town just north of Puerto Vallarta, Mexico. The GILD program is capped at 12 interns and, given the intimate nature of our work and housing, interns tend to become close friends who stay in touch for years to come.

This Summer Internship is an immersive cultural and professional development experience ideal for those seriously interested in the global and community engagement. Students are treated as a part of a small but inventive team, and are entrusted with a great deal of responsibility and



choice. The GILD program wants students to think critically about community and economic development. When working to help those in need, students must first understand who they are, what their goals are, and why. Through projects, personal interaction, and meetings with social entrepreneurs in western Mexico. The GILD program provides students with a personalized internship experience that will help them future career decisions. The GILD program is open to students from all academic majors.

**PROGRAM AUDIENCE**: Space is limited. The program is open to undergraduate students currently enrolled at NIU. All majors are welcome. NIU-HC internships can be customized to meet students' career goals. Previous students have engaged in internships that included community outreach, research, educational initiatives, social entrepreneurship, financial management, marketing and graphic design.

**INSTRUCTION METHOD**: The 3-credit hour course will be structured as a hybrid course with face-to-face meetings occurring on NIU's campus and the rest of the pre-departure course will be online. The course will be taught by Dr. Renique Kersh, with assistance from Grace Anati, Graduate Teaching Assistant. The face-to-face meetings will include critical reflection, presentations about the local and surrounding communities of Mexico's Riviera Nayarit, engaged discussion around topics like voluntourism, community needs, community-based participatory research and service and global scholarship.

Students will be asked to develop a final capstone for the internship experience which will be presented to the larger campus community and will be shared with the Human Connections staff. The first three weeks following the NIU on-campus course, students will engage in an NIU-HC internship experience. The final week of the experience will include an intensive leadership development experience hosted by the staff at Entreamigos in San Pancho, Mexico. This intensive leadership development experience will include skill development, interaction with local leaders and critical reflection.

**PROGRAM ACADEMIC CREDIT:** For satisfactory participation in the program, participants will be registered during the Summer 2018 session for the following courses.

### INTL 201 Study Abroad Programs - NIU Human Connections Global Internship and Leadership Program 3 semester hours

**Description:** The 3-credit hour course will be structured as a hybrid course with face-to-face meetings occurring on NIU's campus and the rest of the course will be online. The face-to-face meetings will include critical reflection, presentations about the local and surrounding communities of Mexico's Riviera Nayarit, engaged discussion around topics like voluntourism, community needs, community-based participatory research and service and global scholarship.

#### **AND**

#### **INTL 301 Internship**

3 semester hours

**Description:** Students will engage in an NIU-HC internship and leadership development experience in Bucerias and the Riviera Nayarit, Mexico. Upon completion of the internship experience, students will be expected to present a poster as a final capstone. The final week of the internship will involve an intensive leadership development experience.

**Procedure:** Students must obtain the internship approval form from the SAO. The approval for must be signed by Dr. Renique Kersh, the GILD program director. Students must also complete the SAO application and any additional SAO required forms.

APPLICATION AND ADMISSION PROCEDURES: The program is open to current NIU undergraduates who meet the NIU general admission requirements, and who are interested in engaging in an intensive global internship and leadership development experience. Students must be in good academic and disciplinary standing at the time of application. Students who are on academic or disciplinary probation are not eligible to participate in study abroad programs. Applicants must participate in the *entire* program and satisfy NIU undergraduate admission and course requirements. Students who are graduating must work with Registration and Records to delay degree conferral date until after the completion of the internship.

Students cannot have any encumbrances against their NIU records. Any encumbrances placed on a student's records by NIU (i.e., Undergraduate Admissions, Bursar's Office, Accounts Receivable, Registration and Records, Office of Student Conduct, Health Services, Parking Services, etc.) must be cleared before a student is granted admission to a study abroad program.

For undergraduate students to be admitted to the program, an applicant's official transcript must be on file in the NIU Study Abroad Office. Students who are currently enrolled at NIU, or who have previously enrolled at NIU, do not need to request an official transcript; the Study Abroad Office will make this request on behalf of the applicant. Questions relating to the admission requirements or transcripts should be directed to the Study Abroad Office.

The online process provides guidance on requesting information, advising, or applying for the program. Non-NIU students will be expected to submit a signature verification form and a copy of their ID to the Study Abroad Office. **\$200 APPLICATION FEE/DEPOSIT:** A \$200 application fee/deposit is required of all applicants. The \$200 consists of \$100 for the non-refundable application fee and \$100 for a program deposit. Both the application fee and the deposit will be applied to the total balance of the program cost. The \$100 deposit is refundable only if the participant withdraws prior to the withdrawal deadline indicated on the program materials or for medical reasons verified by a physician if the withdrawal takes place after the withdrawal deadline.

The \$200 application fee/deposit will be charged to NIU students' NIU Bursar's account. (Checks and money orders cannot be accepted from NIU students.) Non-NIU students must submit a check or money order in the amount of \$200. More detailed instructions can be found on the website.

IMPORTANT – All applications will be categorized as "Pending – No Deposit" until the \$200 application fee/deposit has been received (or, in the case of non-NIU students, once a check has been received). The Study Abroad Office will not consider or process applications without the \$200 application fee/deposit. In order to reserve your place in the program you must submit the \$200 deposit within 14 days of application. After 14 days applications without a deposit will be inactivated.

## APPLICATION DEADLINE: February 1, 2018

Please read the following carefully.

*Space in this program is limited, so early application is recommended.* Qualified applicants will be required to interview with the program director and the Human Connections staff after the February 1 application deadline.

Upon acceptance into the program, applicants must change their status to "Committed" and complete *all* post-decisions items on the Study Abroad Portal in order to be considered an active participant and reserve their place in the program.

Applicants who have not changed their status to "Committed" will be withdrawn from the program.

ACCOMMODATIONS, AIRFARE AND MEALS: Students will stay in comfortable and safe accommodations in Bucerias, which will include kitchen access, double occupancy rooms, and free internet. In addition, they will be located within convenient distance to grocery stores, restaurants, cafe, and the town plaza. During their last week in Mexico, students will relocate to the town of San Pancho, and will stay in hostel-style accommodations inside of the Entreamigos community center. Students will be provided with 12 group meals throughout the program.

**AIR TRANSPORTATION**: Individuals will be responsible for making their own air travel arrangements. Airfare can range from \$300-\$600.



For information regarding airfares and airlines students may wish to check-out additional airfare sites on the Internet.

**Important** - The Study Abroad Office advises all participants that flight reservations for this program should not be booked until:

- a. After the Friday, February 1, 2018 application deadline.
- b. The SAO has accepted the minimum number of participants needed to operate this program.

This advisory is given so that participants do not find themselves financially responsible for airline tickets should it be necessary to cancel the program. (See section entitled, **CANCELLATION OF THE PROGRAM.**)

PASSPORT: --IMPORTANT--All participants must have a passport in order to participate in this seminar. *Important Note: U.S. passports must be valid SIX months beyond the intended stay overseas.* Individuals who do not currently possess a valid passport should apply for one immediately. Information on acquiring a passport is available at the U.S. State Department's Website: <a href="https://travel.state.gov/content/passports/en/passports.html">https://travel.state.gov/content/passports/en/passports.html</a>. U.S. passport holders do not need special visas for this program. Non-U.S. passport holders may need special visas for travel in Mexico and are responsible for obtaining all necessary visas.

**PASSPORT AND ISIC PHOTOS:** You may have your passport photo(s) taken in the NIU Study Abroad Office. Photos are \$5.00 for two photos. Photos must be purchased in multiples of two. Photos are usually developed while you wait. We accept exact cash, personal check or we can charge it to your bursar account. Study Abroad Office hours are 8:00 a.m. – 12:00 p.m. (closed over the lunch hour) and 1:00 – 4:30 p.m. It is strongly recommended that students get an extra pair of photos taken to keep on their person in case of a missing or stolen passport.



**HEALTH REQUIREMENTS/VACCINATIONS:** Students will need to work with the Human Connections to determine if there are any special health requirements for travel. All immunizations and/or other health considerations must be addressed prior to departure. The NIU University Health Service can administer most immunizations.

**NIU INTERNATIONAL TRAVEL INSURANCE PLAN:** Students will be enrolled in the NIU International Travel Insurance Plan through ACE. This plan is required for participation in an NIU study abroad program and will be billed your MyNIU account. It is <u>not</u> possible to waive this mandatory insurance. Coverage will begin two days prior to the program start date and end two days after the official program end date.

INTERNATIONAL STUDENT IDENTITY CARD (ISIC): The International Student I.D. card can provide discounts on international airfare, admission to various cultural sites, and more. The International Student Identity Card also includes a limited health and accident insurance policy which is only valid outside the U.S. Students will have to pay bills at the time of treatment and will be reimbursed later.

The ISIC is **not** included as part of the program cost. If a student wishes to obtain an ISIC, s/he should contact the Study Abroad Office to start the process.

**NIU PROGRAM COST**: The program cost pays for the following cost-related services:

- 1) Housing and 12 group meals
- 2) Excursions and leadership development experience in San Pancho, Mexico
- 3) Six semester hours of NIU undergraduate credit
- 4) NIU International Travel Insurance

#### PROGRAM COST: \$3,750

This amount represents the total in charges and fees that will be paid to NIU for this program. Please note that the following charges will post individually on your MyNIU account:

- Study Abroad Program Charge
- Instructional Cost
- NIU Academic Program Enhancement Fee (if applicable)

\*The Office of Student Engagement and Experiential Learning will provide a \$425 grant per student. Students are also eligible for the Undergraduate Student Engagement Travel Grant. #### ADDITIONAL COSTS TO PARTICIPANTS:

- Airfare
- Cost of acquiring a passport (approximately \$140, including 2 passport pictures).
- Additional costs associated with obtaining a visa for non-U.S. passport holders.
- Immunization fees (if immunizations are required)
- Independent travel and visa costs associated with independent travel.
- Expenses for free-time pursuits.
- Expenses and purchases of a personal nature.

**FINANCIAL AID:** As a participant in a study abroad program through NIU, applicants may be eligible for: Pell Grant, SEOG, Perkins Loan, PLUS Loan, Subsidized or Unsubsidized Stafford Loan, MAP Award or your privately awarded scholarship with consent of awarding organization. Tuition waivers do not apply. **WITHDRAWAL FROM THE PROGRAM**: Applicants withdrawing from the program after February 1, 2018 will not be refunded the \$200 program deposit.

Applicants withdrawing from the program after this date will also be held accountable for any funds obligated to overseas vendors and agents on the applicant's behalf. This provision is in effect even if the applicant has not submitted the \$200 deposit or additional payments, and if the applicant is applying for financial aid.

If the applicant must withdraw after February 1, 2018 for medical reasons, funds obligated on their behalf to overseas vendors can only be refunded if:

- 1) The request is submitted to the Study Abroad Office in writing and accompanied by a signed statement stating that travel is not advised from a physician on the physician's letterhead; **and**
- 2) NIU is able to obtain refunds from overseas vendors and agents; and
- 3) The program still has the minimum number of participants required to operate.

**CANCELLATION OF THE PROGRAM:** The Study Abroad Office reserves the right to cancel this program if the minimum required enrollment is not attained. If, prior to the commencement of the program, a U.S. State Department Travel Warning is issued for the country where NIU-HC internship has been selected, all applicants will be notified promptly of the warning and the possibility of cancellation of the program. Students may also choose a different internship site. If, during the course of the program, a U.S. State Department Travel Warning is issued for the selected internship site students will be promptly notified of the warning and the advisability of canceling the program.


#### **Frequently Asked Questions**

- 1. Is the GILD program a paid internship? No, there is a cost associated with the internship program, which covers your housing, most of your food and several excursions for the trip. You will need to cover your own airfare.
- 2. Do I have to take the 3 hour INTL 201 pre-departure course and the 3 hour internship course? Yes, both courses are required. The INTL 201 course is the 3 hour pre-program course that takes place from April 9 May 7. It's an online course that will help prepare you for your internship. The 3 hour internship course takes place from May 14 June 10. You must complete the "Internship Credit Approval Form." The Study Abroad Office will register you for both courses. The total credits for this program equal 6 credits.
- 3. What can I expect from the internship? The Human Connections team will provide you with an experience based on your skills, interest and expertise, however the majority of the internship will be for students interested in global and community engagement and outreach. The final week of the program will involve a leadership development program at Entreamigos, a community center in San Pancho, Mexico.
- 4. Is funding available for this experience? Applicants may apply for the Study Abroad Travel Grant (application deadline: April 15, 2018) as well as any summer financial aid and/or loans. If you are a student in the College of Business, travel funds are available through the college. If you are a student in the College of Liberal Arts and Sciences, you are welcome to apply for funding through the Student Engagement Fund (application deadline: March 15, 2018). Students can also apply for funds through the USET. - 5. What about safety concerns? Bucerias and San Pancho, Mexico are located near Puerta Vallarta. Both are safe destinations. NIU follows the U. S. Department of State recommendations very closely and will not send students to any destinations that have been deemed unsafe.
- 6. What are the program dates? The pre-departure course (INTL 201) will begin in early April and will be held mostly online. The actual internship in Mexico will run from May 14 to June 9.
- 7. What if I would like to stay in Mexico beyond June 10? You are welcome to stay beyond June 10, however, you will no longer be participating in the NIU program and should plan your own accommodations and insurance coverage.

#### NIU-Human Connections Global Internship and Leadership Development Program

Eight NIU students – **Timi Adebjoe**, **Luke Arrington**, **Raven Bryant**, **Hopkins**, **Yannick Koua**, **Dexter Matthews**, **Janel Pilate** and **Yuije Sansone** – traveled in January of 2016 to San Pancho, Mexico and began a journey that now becomes their legacy.

While in San Pancho, the students were hosted by an organization called Entre Amigos where they not only learned about themselves, but they learned about the tenacity and commitment of the people of San Pancho. For many of the students, the trip provided their first excursion outside the United States. And, although the

eight originally hailed from inner-city Chicago, their journey to Mexico offered an eye-opening look at what lies just beyond the border. Following this experience, Randiss Hopkins, then traveled to Bucerias, Mexico where he interned for Human Connections, a non-profit organization that connects local people with international audiences. Both experiences were life-changing and when he returned to the United States, he and several other students made it their mission to ensure that other NIU students would have an opportunity to engage in a similar experience. From here, The NIU-Human Connections Global Internship and Leadership Development Program was born and represents

their legacy and desire to provide a cost-effective avenue whereby NIU students can gain practical work experience and critical leadership skills. Through this four week program, students will engage in three weeks of internship with Human Connections in Bucerias and one week of leadership development and civic engagement with Entre Amigos in San Pancho.
