AGEN, FRANCE

MAY 30 - JULY 10, 2019*



The NIU College of Law Summer Program in Agen, France is approved and accredited by the American Bar Association. This will be the 24th annual summer program offered by Northern Illinois University's College of Law, the Université Bordeaux, and the NIU Study Abroad Office.

PROGRAM DATES: The program will officially begin in Agen, France on Thursday, May 30, 2019. Students will be responsible for making their own air travel arrangements for arrival in Agen on May 30 in time for an introductory reception at 6:00 PM and dinner to follow at L'Imprevu. There will be a final dinner on July 9. *Students may depart Agen on Wednesday, July 10 or Thursday July 11, 2019. Please note that a flight on July 10 may necessitate departing Agen the night before or very earl in the morning.

PROGRAM OBJECTIVES: This program is designed to give non-French speaking students an understanding of the French civil law system and the legal system of the European Union. Language of instruction is English. Classes will be conducted at the facilities of the Juridical Studies Center of Agen (Université Bordeaux).

PROGRAM DIRECTOR: Professor David Taylor is the director of the program. He is a Distinguished Teaching Professor and serves as serves as the Director for Skills Training at the College of Law, where he teaches Civil Procedure, Evidence and Trial Advocacy. His teaching interests lie in the French Civil Law System, with an emphasis on French court systems inquisitorial trial process.

FRENCH FACULTY: A major strength of the Agen program is that it makes extensive use of French law faculty and practitioners to offer lectures on selected topics. Regular lecturers come from the University of Bordeaux, the University of Paris, and the Agen practicing bar. Students are exposed to the study of law in the European fashion where the lecture/discussion mode predominates over the American case presentation method. The American faculty are present and participating when their French colleagues are lecturing.

Professor Sébastien Platon is the French academic director in Agen and will lecture in the program this year. He is a professor of French and European public law at the Université Bordeaux and a member of the Center for Research and European and International Documents. He is a specialist in the law of the European Union.




Additional NIU Faculty: It is anticipated that other members of the College of Law faculty will join the program and offer class sessions. These may include Professor David Rosenfeld, as well as other College of Law faculty.

FIELD TRIPS: Both academic and leisure field trips are being planned as part of the program. Past academic trips have included court observation in both local and national courts (Agen and Paris), "behind the scenes" presentations at the French Senate and National Assembly, the French Supreme Court, and National Council in Paris; and a visit to the national judicial school in Bordeaux. Past leisure trips have included visits to the mountains and the Atlantic beaches. As part of the total experience of immersion into the study of law abroad, bi-lingual French law students may also accompany American law students on many field trips and social outings.

JURIDICAL STUDIES CENTER OF AGEN: The university buildings in Agen are quite new (entirely rebuilt and renewed in 1994), accessible to persons with disabilities, and provide spacious classrooms. The Center's administrative offices are within close proximity of the classrooms and students may contact the Center staff for assistance of any type.

AGEN is located on the Garonne River, in the Aquitaine region. Agen was originally the capital of a Gallic tribe conquered by Julius Caesar and an important Roman trading center. Later it was made the capital of the county of Agenais. Agen became the seat of a bishopric in the 10th century; construction of the cathedral here was begun during the 12th century. Agen is a rich agricultural area, famous for its prunes (pruneaux d'Agen), renaissance mansions with art museums, and the Saint-Caprais Cathedral. Aquitaine Region: The region's history began thousands of years ago when Cro-Magnon man lived in the caves of the Périgord and left cave paintings in sites such as Lascaux and Les Eyzies. More recent remnants of Aquitaine's history date from the time of Eléonore of Aquitaine, consort of Louis VII, King of France. When she married Henry Plantagenet, who became King of England in 1154, there began several centuries of conflict between the French and English for control of Aquitaine. Today, the



fortified villages and castles built during this time offer charm to the winding countryside and provide interesting stops along the road.

ACADEMIC CREDIT: For satisfactory participation in the program, participants will receive a Certificate of Completion from NIU College of Law for **six** hours of law school credit. Course performance will be evaluated by the NIU faculty in the same manner in which on campus courses are evaluated. The courses taken while participating in this program *cannot* be audited. Participation in a summer study abroad program is unlikely to accelerate graduation.

LAW 699: Civil Law and Civil Lawyers: The French Experience 3 semester hours

Description: What England is to the Common Law world, France is to the other great legal tradition: the Civil Law. This course is a focused, in-depth examination of the French legal system in action. Selections from *Code Civil* and other texts are examined, particularly as they relate to the unique structure and functioning of the French system of judicial, administrative and constitutional jurisdictions. The distinctively different role of judges in a non-common law system is examined as are the roles, formation and ethics of the various French legal professions. Judges and lawyers are also observed in on-site court sessions. Selected topics in French substantive law are studied from a comparative perspective.

LAW 699B: The Legal System of the European Union

3 semester hours

Description: The legal system of the European Union overlays the domestic legal systems of France and other European Union member states. This course examines the development of the legal and institutional structure of the European Union from the Treaty of Paris (1951) through the Treaties of Rome (1956), Maastrich (1993), Amsterdam (1999), Nice (2003), and subsequent treaties. In addition, this course considers the relationship of the law of the European Union to the domestic law of the member states and examines selected substantive aspects of European Union Law.

ELIGIBILITY/ADMISSION REQUIREMENTS: The program is open to all NIU College of Law students. Applicants must meet NIU College of Law GPA requirements for good standing (2.2). Students whose GPA was below 2.2 at the end of the semester prior to the program will be reviewed on a case-by-case basis.

Students must be in good disciplinary standing at the time of application. Students who are on disciplinary probation are not eligible to participate in study abroad programs.

Students cannot have any encumbrances against their NIU records. Any encumbrances placed on a student's records by NIU (i.e., the Graduate School, Undergraduate Admissions, Bursar's Office, Accounts Receivable, Registration and Records, Office of Student Conduct, Health Services, Parking Services, etc.) must be cleared before a student is granted admission to a study abroad program.

\$200 APPLICATION FEE/DEPOSIT: A \$200 application fee/deposit is required of all applicants. The \$200 consists of \$100 for the non-refundable application fee and \$100 for a program deposit. Both the application fee and the deposit will be applied to the total balance of the program cost. The \$100 deposit is refundable only if the participant withdraws prior to the withdrawal deadline indicated on the program materials or for medical reasons verified by a physician if the withdrawal takes place after the withdrawal deadline.

The \$200 application fee/deposit will be charged to NIU students' NIU Bursar's account. (Checks and money orders cannot be accepted from NIU students.) More detailed instructions can be found on the website.

IMPORTANT – All applications will be categorized as "Pending – No Deposit" until the \$200 application fee/deposit has been received. The Study Abroad Office will not consider or process applications without the \$200 application fee/deposit. In order to reserve your place in the program you must submit the \$200 deposit within 14 days of application. After 14 days applications without a deposit will be changed to inactive.

Application Deadline: FEBRUARY 22, 2019

- Students are urged to apply early as <u>there are only 25 spaces available.</u> <u>Early application is strongly encouraged</u>.
- Upon acceptance into the program, applicants must change their status to "Committed" and complete *all* post-decisions items on the Study Abroad Portal in order to be considered an active participant, reserve their place in the program, and be registered for the program courses by the Study Abroad Office. Note: Financial Aid and loans will not be disbursed until students are registered for their courses.
- Applicants who have not changed their status to "Committed" will be withdrawn from the program.

HOUSING: Housing in Agen will be at Appart' City, a somewhat small residence hotel in the heart of Agen. Each student will have an air-conditioned room, with private bath and a small kitchen. https://www.appartcity.com/fr/destinations/aquitaine/agen/agen-centre.html. Most lunches and evening meals are provided as part of the program cost. (Program housing is not available prior to 3:00 PM, May 30, 2019. Students will be expected to depart program provided housing by 11:00 AM on July 10 or July 11, 2019).

MARRIED LAW STUDENTS, ACCOMPANYING SPOUSES, CHILDREN, OR GUESTS:

The program, including estimated costs, is based on a single unaccompanied individual law student. There are no provisions made in the program for accompanying spouses, children or other guests. In the event a law student wishes to be accompanied by a spouse or children or other guests, all arrangements for housing, transportation, food, insurance, childcare, leisure activities, etc., are the responsibility of the student. NIU is not responsible for logistics for anyone other than student participants in the program. Any student wishing to be accompanied by a spouse, child or other guest should contact the program director for suggestions.

TRANSPORTATION: Individuals will be responsible for making and paying for their own travel arrangements between the U.S. and Agen. Students may choose to fly from the U.S. to Paris (CDG) and take the TGV (fast train) from Paris (Gare Montparnasse) to Agen. (The train trip takes approximately 3 hours. The train stops in Bordeaux. It is preferable to take the direct train and not have to switch in Bordeaux. The fare is approximately \$100). Other options would include taking connecting flights arriving in Bordeaux or Toulouse and taking the TGV from either location to Agen. (Either route is approximately one hour and costs approximately \$35). Participants should keep in mind that in order to arrive in Agen in time for the official beginning of the program May 30, they should plan to depart the U.S. no later than May 29, 2019.

Important - The Study Abroad Office advises all participants that flight reservations for this program should not be booked until:

- a. After the February 22, 2019 application deadline;
- b. The minimum number of participants have committed to participate in the program.

This advisory is given so that participants do not find themselves financially responsible for airline tickets should it be necessary to cancel the program. (See section entitled, **CANCELLATION OF THE PROGRAM.**)

PASSPORT: All participants must possess a valid passport in order to participate in this program. Individuals who do not currently possess a valid passport should apply for one immediately. Information on acquiring a passport is available at the U.S. State Department's Website: http://travel.state.gov/content/passports/en/passports.html. U.S. passport holders do not need special visas for this program. Non-U.S. passport holders may need special visas for travel in Europe and are responsible for obtaining all necessary visas.



PASSPORT PHOTOS: Passport photo(s) can be taken in the NIU Study Abroad Office. Photos are \$5.00 for two photos. Photos must be purchased in multiples of two. Photos are usually developed while you wait. Photos can be paid for with exact cash, personal check or charged to your NIU bursar account. Study Abroad Office hours are 8:00 a.m. – 12:00 p.m. (closed over the lunch hour) and 1:00 – 4:30 p.m. It is strongly recommended that students get an extra pair of photos taken to keep on their person in case of a missing or stolen passport.

NIU INTERNATIONAL TRAVEL INSURANCE PLAN: Students will be enrolled in the NIU International Travel Insurance Plan through ACE. This plan is required for participation in an NIU study abroad program and will be billed your MyNIU account. It is <u>not</u> possible to waive this mandatory insurance. Coverage will begin two days prior to the program start date and end two days after the official program end date.

HEALTH REQUIREMENTS/VACCINATIONS: While there are no required vaccines for entry to France, routine vaccinations are recommended by the Center for Disease Control. See information for students traveling on <u>Study Abroad programs</u> and <u>Health Information for Travelers to the France</u>.

Students should also seek advisement from the <u>DeKalb County Health Department (DCHD)</u> for immunization and travel health information. The DCHD can administer most immunizations. Contact the DCHD at least eight weeks before the program begins to allow time for immunizations to take effect. Some vaccines need to be given over a period of months, so participants in this program must START EARLY!

NIU PROGRAM COST: The cost of the program in Agen includes the following:

- 1) Housing accommodations and meals (breakfast, most weekday lunches and most dinners) as described.
- 2) Land transportation to all program-related sites, including Paris, Bordeaux and San Sebastian, Spain.
- 3) Admission fees to all program-related cultural and historical sites.
- 4) Six hours of NIU credit.
- 5) NIU International Travel Insurance.

PROGRAM COSTS: \$6,700*

- *This amount represents the total in charges and fees that will be paid to NIU for this program. Please note that the following charges will post individually on your MyNIU account:

ADDITIONAL COSTS TO PARTICIPANTS: Other expenses that will be incurred by the participants include:

- Airfare
- Meals not provided as part of the NIU program package

- Cost of acquiring an American passport
- Books and supplies
- Purchases of a personal nature.

For purposes of financial aid, these costs as estimated for summer 2018 were as follows: airfare \$1,350; meals not provided by the program \$675; cost of acquiring an American passport (including pictures) \$130; books and supplies \$125; and personal expenses \$1,800. You must contact the International Affairs Business Manager in order for a budget for the 2019 program to be sent to the Student Financial Aid Office on your behalf.

FINANCIAL AID: As a participant in a study abroad program through NIU, applicants may be eligible for: Pell Grant, SEOG, Perkins Loan, PLUS Loan, Subsidized or Unsubsidized Stafford Loan, MAP Award or you're privately awarded scholarship with consent of awarding organization. Tuition waivers do not apply.

If you plan to apply for aid or loans to supplement this study abroad program you must contact the NIU Financial Aid and Scholarship Office in Swen Parson 245, (815) 753-1395 to discuss your current aid package and what you might be eligible for during the Summer term. ORIENTATION INFORMATION: An *Orientation Handbook* will be distributed by the Study Abroad Office in May of 2019.

WITHDRAWAL FROM THE PROGRAM: Applicants withdrawing from the program after February 22, 2019 will not be refunded the \$100 program deposit.

Applicants withdrawing from the program after this date will also be held accountable for any funds obligated to overseas vendors and agents on the applicant's behalf. This provision is in effect even if the applicant has not submitted the \$100 deposit or additional payments, and if the applicant is applying for financial aid.

If the applicant must withdraw after February 22, 2019 for medical reasons, funds obligated on their behalf to overseas vendors can only be refunded if:

- 1. The request is submitted to the Study Abroad Office in writing and accompanied by a signed statement stating that travel is not advised from a physician on the physician's letterhead; **and**
- 2. NIU is able to obtain refunds from overseas vendors and agents; and
- 3. The program has the minimum number of participants required to operate.

STANDARD PROGRAM CANCELLATION POLICY: The Study Abroad Office reserves the right to cancel this program if the minimum required enrollment is not attained. If, prior to

the commencement of the program, a U.S. State Department Travel Advisory is issued for France, all applicants will be notified promptly of the warning and the possibility of cancellation of the program. If, during the course of the program, a U.S. State Department Travel Advisory is issued for France, students will be promptly notified of the warning and the advisability of canceling the program.
